Fishing Holdings, LLC dba Triton Boats ("Triton") warrants to you, the first International (outside of North America) retail purchaser of this 2016 model year Triton fiberglass boat and/or steel trailer or a second International retail purchaser as noted below ("you"), that it will repair or replace, at its sole discretion, defects in materials or workmanship that occur and are reported to Triton, or its factory authorized fiberglass dealer, within the applicable limited warranty periods, subject to the terms, conditions and exclusions set forth below. Your acceptance of delivery of the warranted Triton fiberglass boat and/or steel trailer constitutes your acceptance of the terms of this limited warranty.

This limited warranty is the sole and exclusive express warranty from Triton regarding your 2016 Triton fiberglass boat and/or steel trailer, and there are no express warranties which extend beyond those outlined in this limited warranty. There are no implied warranties from Triton unless otherwise required under applicable law, and ALL IMPLIED WARRANTIES (INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE) ARE EXCLUDED AND DISCLAIMED WHERE ALLOWED BY APPLICABLE LAW. ANY IMPLIED WARRANTIES (IF APPLICABLE) ARE LIMITED TO THE MINIMUM PERIOD OF TIME ALLOWED UNDER APPLICABLE LAW. Retail purchasers in the European Union (EU) may have legal rights under applicable national legislation and the Consumers Protective Directive 1999/44/EC of the European Parliament and of the Council of 25 May 1999, governing the sale of consumer goods, which are not affected by this limited warranty. Retail purchasers in other countries may also have legal rights which are not affected by this limited warranty.

Coverage Under This Limited Warranty:

Structural Hull Limited Warranty: The limited warranty period for Structural Hull Defects (defined below) runs for five (5) years. The "Hull" shall mean the single fiberglass molded shell and integral structure within that shell, including stringers, floorboards, transom and related structural reinforcements, all of which are below the Hull flange (i.e. gunwale). A "Structural Hull Defect" shall mean a substantial defect in the fiberglass boat's Hull, which causes the fiberglass boat to be unfit or unsafe for general use as a pleasure craft under normal operating conditions.

Non-Structural Parts and Components Limited Warranty: The limited warranty period runs for two (2) years for the following non-structural parts and components: _

1. Fiberglass boat wiring harness and switches
2. Certain instrumentation: tachometer, speedometer, trim gauge, volt gauge, fuel gauge and water pressure gauge
3. Fuel tanks
4. Deck hardware
5. Fiberglass boat lights, aerators, bilge pumps, hoses, clamps and fittings
6. Steering head and cables
7. Triton steel trailer

The applicable limited warranty period for both the first and second (if applicable) International retail purchasers runs from the date of delivery of the fiberglass boat and/or steel trailer to the first International retail purchaser, provided that the boat and/or steel trailer is delivered to that purchaser within twenty-four (24) months from the date of its manufacture. For a fiberglass boat and/or steel trailer delivered to that purchaser more than twenty-four (24) months after the date of its manufacture, the limited warranty period runs from the date of its manufacture not from the date the fiberglass boat and/or steel trailer was delivered to that purchaser. All limited warranties run concurrently.

This limited warranty extends only to the first International retail purchaser. However, it may be transferred to a second International retail purchaser for a non-refundable recording fee of \$100(US) (made payable to your authorized fiberglass dealer), which must be paid within fifteen (15) days of purchase, provided the second International retail purchaser purchases the fiberglass boat and/or steel trailer from the original purchaser or an authorized Triton fiberglass dealer. Proof of purchase date is required. The transfer must occur within five (5) years of the original retail sale to the first International retail purchaser. This limited warranty may only be transferred **once**. Triton reserves the right to reject a limited warranty transfer request for a Triton fiberglass boat and/or steel trailer that has been damaged, neglected or otherwise previously excluded from limited warranty coverage.

THIS LIMITED WARRANTY DOES NOT COVER:

1. A fiberglass boat and/or steel trailer purchased from any party other than an authorized Triton fiberglass dealer or the first International retail purchaser.
2. A fiberglass boat and/or steel trailer, including its components, that has been altered or modified so as to adversely affect its operation, performance or durability, as determined by Triton, or a fiberglass boat and/or steel trailer that has been salvaged, declared a total loss, or a constructive total loss for any reason not covered in this limited warranty.

3. Any damage resulting from an accident or impact with another object or any damage caused by an act of nature.
4. Damage, breakage and leakage around windshields, hatches or other designed openings.
5. Gel coat finishes including blistering, chalking, discoloration, cracking, crazing, fading, or stars; wood finishes (varnish, stains and paints); plastics; plated or painted metal; stainless steel finishes and anti-fouling bottom paint.
6. Damage (including rainwater leakage), deterioration, fading, fraying, tearing, wearing or shrinkage of carpet, upholstery (including fabric and vinyl), exterior canvas tops, enclosures, weather covers or other soft goods.
7. A fiberglass boat that has been overpowered according to the maximum recommended engine horsepower or overloaded in excess of the maximum limits as stated on the Capacity Plate (if applicable).
8. A fiberglass boat with an engine setback that is in excess of six (6) inches on a 179 TRX; 189 TRX; 18 TRX; 186 Escape; 210 Escape; 220 Escape; 186 Allure; 186 Fishhunter; 206 Fishhunter; or 216 Fishhunter; or ten (10) inches on a 19 TRX; 20 TRX; 21 TRX; 22 TRX; 220 LTS PRO, 240 LTS PRO or 260 LTS Pro. **Note: Any Triton fiberglass boat equipped with an Evinrude G2 engine may not be equipped with an engine setback that is in excess of six (6) inches. Any Triton fiberglass boat equipped with a Mercury Verado engine may not be equipped with an engine setback that is in excess of four (4) inches.**
9. Estimated characteristics such as weight, speed and fuel consumption or other estimated performance characteristics.
10. Any fiberglass boat and/or steel trailer that has been misused or used in a negligent manner; used for racing, speed or endurance contests; used for rental; used without normal maintenance; operated contrary to any instruction furnished by Triton or operated in violation of any federal, state, local, or other governmental agency laws, rules or regulations.
11. Dealer preparation, cleaning, final adjustments and alignments in preparing the fiberglass boat and/or steel trailer for delivery.
12. Trailer tires, paint chipping, rust/corrosion, axle alignment and trailer components manufactured by companies other than Triton.
13. Damage to trailers from use in salt or brackish water, except those trailers designed for salt/brackish water use.
14. Damage caused by improper trailering or mismatching of a Triton fiberglass boat to a trailer; or failure to properly secure the fiberglass boat to a trailer.
15. Engines, powertrains, outdrives, controls, propellers, batteries, trailers and other equipment, accessories or components that are not manufactured by Triton, whether or not they are warranted by other manufacturers. **Note:** it is the purchaser's responsibility to complete any limited warranty registration procedure that may be applicable to these components with the component manufacturer.
16. Any failure or defect arising from a previous repair made by a non-authorized service provider, unless preapproved by Triton.
17. Structural welds in the T-top or hardtop tubular frames that have been modified or forced to bear excessive weight.
18. Any defect that results in the redesign of the Triton fiberglass boat.

THE SOLE AND EXCLUSIVE REMEDY UNDER THIS LIMITED WARRANTY AND ANY APPLICABLE IMPLIED WARRANTY IS THE REPAIR OR REPLACEMENT, AT TRITON'S SOLE OPTION, OF WARRANTED PARTS AND COMPONENTS. TRITON EXCLUDES AND DISCLAIMS ANY LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING LOSS OF TIME, INCONVENIENCE, INSTALLMENT PAYMENTS, INSURANCE PAYMENTS, MARINA FEES, RETAIL CHARGES, TRAVEL EXPENSES, LOSS OF USE, HAUL OUT, LAUNCH, TOWING AND/OR STORAGE CHARGES, LOSS OF OR DAMAGE TO PERSONAL PROPERTY OR OTHER SIMILAR COSTS AND EXPENSES, OR ANY CLAIM NOT SPECIFICALLY COVERED BY THIS LIMITED WARRANTY. Any legal action alleging breach of any applicable warranty coverage must be brought within one (1) year from the date the alleged breach first occurred, or the shortest period of time allowed under applicable law. Any claim by a retail purchaser in the EU that the fiberglass boat was nonconforming at the time of delivery must be made within two (2) years from the date of delivery.

In order to activate limited warranty coverage on the fiberglass boat and/or steel trailer, the first International retail purchaser must warranty register the fiberglass boat and/or steel trailer through an authorized Triton fiberglass dealer via Triton's online dealer extranet, within fifteen (15) days of delivery of the fiberglass boat and/or steel trailer. All information received by Triton via the limited warranty registration or transfer process shall be the property of Triton, and submission of information, directly or indirectly, via the limited warranty registration process shall, to the extent permitted by applicable law, be deemed to constitute consent by the purchaser and fiberglass dealer to Triton's use of such information at any time for all purposes allowed by law, including use of that information by third parties selected by Triton. You may opt to not have your personal information disclosed to third parties and/or to not receive marketing materials from Triton by sending a written request to: Triton Boats Warranty Department, PO Box 179, Flippin AR 72634. To obtain limited warranty service, you must return the fiberglass boat and/or steel trailer, including any alleged defective part, to an authorized Triton fiberglass dealer. Triton must receive written notice of all limited warranty claims prior to the expiration of this limited warranty and be allowed an opportunity to resolve them. The authorized Triton fiberglass dealer will carry out the limited warranty procedures (e.g. repairs, claims submissions to Triton etc.) on the purchaser's behalf. All limited warranty work must be performed at an authorized Triton fiberglass dealer, at the Triton factory, or at another repair facility that is approved by Triton. You are responsible for the expenses associated with transporting the fiberglass boat to and from the repair facility.

NOTE: Triton will complete repairs/replacements covered under this limited warranty during the first year after delivery of the fiberglass boat and/or steel trailer to the first International retail purchaser, at no charge to the purchaser. After that, the first or second (if applicable) International retail purchaser must pay a service charge of \$50 per claim to the authorized Triton fiberglass dealer for service performed under this limited warranty. (There is no charge for service appointments solely for any rework from previous service appointments.)

Triton does not authorize any person or persons (except a senior management level employee of Triton), including Triton fiberglass dealers, to change the terms of this limited warranty. (Note that your authorized Triton fiberglass dealer is an independent business, authorized to sell and service Triton products, but is not an agent of Triton.) Triton reserves the right to change or improve the design or manufacture of Triton fiberglass boats and/or steel trailer without obligation to modify any fiberglass boat and/or steel trailer previously manufactured.
