



## Warranty Transfer Request to 2<sup>nd</sup> Owner

The remainder of the limited warranty available to 2<sup>nd</sup> owners is based upon the terms of the warranty to the specific product.

- Up to 2013 model year, the limited warranty regarding the hull, interior hull stringers and transom is transferable to a second owner depending on time in service. The remaining warranty available will be structural only. No cosmetic warranty is available to a 2<sup>nd</sup> owner.
- For certain models starting with 2014 model year, 2<sup>nd</sup> owners will be entitled to the remainder of the original warranty as stated in the warranty for that product.

A \$100.00 warranty transfer fee is applicable at the time of transfer. Transfer request must be made in writing to White River Marine Group® Warranty Transfer, 2500 E. Kearney, Springfield, MO 65898 within 30 days of purchase.

When purchased through a White River Marine Group dealer, the \$100 transfer fee may be waived on 2013 model year product and prior. To qualify for the waiver, the request must be made within 15 days of purchase. Transfer requests on units sold by your dealership and received after 15 days will have the \$100 transfer fee charged to dealer's open account. Dealer may submit the application by faxing to:

- ✓ Copy of Proof of Purchase (Bill of Sale) containing Seller & Buyer's Information (Names, Addresses, Phone Numbers) and Date of Purchase.
- ✓ \$100.00 Warranty Transfer Fee (check # \_\_\_\_\_)

Printable Warranty Registration Transfer and Trade-In Evaluation forms are attached. Printable warranty statements can be found on White River Marine Group dealer portals by model and year.

\* **Please Note:** Some 2014 newer models will require completion of inspection process by an authorized White River Marine Group dealer. To find if this boat requires an evaluation by an authorized White River Marine Group dealer, please refer to the boat's original Warranty Statement.
